Citizens may raise matters with their elected representatives directly or in writing. Depending on the matter, this may include presenting a petition calling on council to respond via a local law or by-law.  Any local laws passed by council are designed to ensure that the actions of an individual or group do not have an adverse impact on the rest of the community, and only apply within the municipality in which they are passed, though many councils share similar laws.  The process for a council to create a new law is that it must be advertised publicly and consider any submissions it receives before implementing the law. It cannot duplicate or contradict a federal or state law. The law, once passed, has a 10-year life unless it is revoked sooner or renewed to remain valid. This ensures that local laws remain current and suitable to the purpose for which they were originally made. Council must make all copies of local laws available for public inspection. The current City of Ballarat local laws can be located on council's website.
