#### EXECUTIVE SUMMARY

This report outlines the process and statutory requirements for the election of the Mayor for the City of Ballarat in accordance with Section 71 of the *Local Government Act 1989* and Part B of the Meeting Procedure Local Law 2018.

The process will be in two parts.

#### Part One: Determination of Mayoral Term

Prior to electing the Mayor, Council is required to determine the Mayoral term. This can be one or two years. As there is only one year until the end of the Council term, the Council may only elect the Mayor for a one-year term.

#### MOTION:

#### Council resolves that the Mayoral term be for one year.

#### Part Two: Election of Mayor

In accordance with the City of Ballarat Meeting Procedure Local Law 2018, nominations for the position of Mayor were submitted by 5.00pm, Monday 21 October 2019. The Chairperson will call forward the nominations and conduct the election.

#### 7.2. ELECTION OF DEPUTY MAYOR 2019/20

#### **EXECUTIVE SUMMARY**

This report outlines the process and requirements for the election of the Deputy Mayor if determined by Council.

In accordance with section 71 of the *Local Government Act 1989* (the Act) Councillors are not required to elect a Deputy Mayor, however, may choose to appoint a Deputy Mayor for the purpose of assisting the Mayor with official duties.

It is noted that no additional allowance is payable.

The process for the election of Deputy Mayor will be in two parts.

#### Part One: Determination of the position of Deputy Mayor

#### MOTION:

That Council determine to proceed with the election of a Deputy Mayor for the 2019/20 term.

#### Part Two: Election of Deputy Mayor

In accordance with the City of Ballarat Meeting Procedure Local Law 2018, nominations for the position of Deputy Mayor were submitted by 5.00pm, Monday 21 October 2019.

On the proviso that Council has determined in part one above, to fill the position of Deputy Mayor, the Mayor will call forward the nominations and conduct the election.
