

## Building a new home in ballarat west

Community Infrastructure Levy payment of \$1,210 must be paid prior to a Building Permit being issued.

The City of Ballarat has introduced the Ballarat West Development Contributions Plan for development of land in Ballarat West. The Ballarat West Development Contributions Plan including the Community Infrastructure Levy was approved by the Minister on October 31, 2014.

#### What is the Community Infrastructure Levy?

There is a requirement for new homeowners in the Ballarat West Growth Area to pay the Community Infrastructure Levy prior to the issue of a building permit for the construction of a dwelling. The levy is a one-off payment, as specified in the *Victorian Planning and Environment Act 1987* and is mandated under Section 24(5) of the *Building Act 1993*.

#### What does my \$1,210 pay for?

The Community Infrastructure Levy is a contribution towards the community facilities in the Ballarat West Growth Area such as multi-purpose community hubs, early years hubs, recreational facilities and sports pavilions.

## Does this levy only apply to the City of Ballarat?

**No.** This is a levy applied in accordance with the Planning and Environment Act 1987 for growth area councils. The Community Infrastructure Levy contribution is a levy payable for every new home built in the growth areas across Victoria.

#### Will the City of Ballarat be contributing too?

**Yes.** The City of Ballarat will pay a share of costs for community infrastructure. It will pay more than 50% of the costs for many community and sporting facilities.

**Please note:** The City of Ballarat actively encourages developers to pay the Community Infrastructure Levy upfront, on creation of new lots, to remove this requirement on the new homeowner.

# How do I pay the Community Infrastructure Levy?

A schedule of fees will be mailed out to the applicant when Council receives notification that a private building surveyor has been appointed for construction of a new dwelling.


