Message from Mayor and Councillors

It is a pleasure to present City of Ballarat's Advocacy Priority Projects Pipeline.

These projects will bring quality-oflife benefits for Ballarat residents and for people in our region who regularly use our city's community, educational, health, recreation and cultural facilities and services.

Ballarat is a community and service centre for 160,000 people in the Central Highlands Region and 300,000 people living in Western Victoria.

These projects will have a profound, and in some cases, generational impact, delivering economic, environmental and social benefits far beyond the boundaries of our municipality.

Revenue Sources

With limited capacity to raise revenue (rate capping), and with fees and charges controlled by legislation, Councils are increasingly dependent on grants funding, election commitments and budget allocations to fund major infrastructure projects.

These factors, coupled with inflation and increasing construction costs, limit City of Ballarat's capacity to deliver key projects without funding from the Victorian and Australian Governments.

Successful Partnerships

In recent years City of Ballarat has successfully partnered with the Victorian and Australian Governments to facilitate the delivery of essential infrastructure across the municipality.

Our local Members of Parliament have been strong advocates for these projects - their support has been invaluable. Thank you on behalf of the people of Ballarat.

City of Ballarat will continue to work with both levels of government to secure funding to deliver City of Ballarat's Advocacy Priority Projects Pipeline.

Project Description

Runway Upgrade

The Ballarat Airport STAMP identifies a series of priority actions to upgrade Ballarat Airport's capability and the services it can provide to Ballarat and the region.

The highest priority action from the STAMP is stage 2 of the runway upgrade, which involves reconstruction of the existing 1,250 metre section of the airport's main runway.

This section – which was built at the start of World War 2 – is at the end of its operational life and needs replacement. The present runway strength only allows light aircraft to take off or land.

Terminal and Apron: The existing terminal and apron area (where aircraft are parked, loaded, and unloaded) needs to be upgraded to accommodate existing aeromedical services and large passenger aircraft which could be attracted to operate into Ballarat Airport when the runway capability permits.

These upgrades will ensure regulatory compliance and create an efficient connection between the airport's landside areas (accessible to the public) and airside areas (accessible only to airport staff and passengers).

Why should Governments invest in this project?

Essential services – medical transport services

The ageing infrastructure at the airport needs to be upgraded so the full suite of medical transport services can continue to be provided to residents living in western Victoria.

These services include Air Ambulance neonatal and paediatric patient transfers to Melbourne, and non-emergency patient transfers. Without upgrades, the risk is some patients will have to be transferred by road or wait longer for a smaller aircraft to become available.

A Royal Flying Doctor Service pilot made these observations about the Ballarat Airport main runway:

Of all the runways we go to in Victoria, this is the roughest and causes the most damage to aircraft. If it continues as it is, we won't be able to fly into Ballarat.

Essential services – bushfire response

An upgraded runway will enable most aircraft types operated within Australia to fly in and out of Ballarat Airport. This may mean having the large aerial tanker (LAT) fleet based in Ballarat, much closer to fire risk areas than where these aircraft are currently based.

This would greatly reduce the time it takes for LATs to reach bushfires in the Central Highlands and Western Victoria, areas which are often at risk of major bushfires for many months each year.

Investment Attraction

Completing the upgrade to the remaining runway would allow further exploration of the opportunity to attract a passenger service in and out of Ballarat. This is supported by data showing that there is currently between 1200–1600 people a day from the wider Ballarat catchment flying out of Melbourne Airport (Tullamarine) each day. Ballarat is presently the 17th largest city in Australia – but is one of few places in the top 50 by population without a regular airline service.

Economic benefits

The evidence from localities around Australia indicates that regional aviation positively impacts on the local economy, in particular the earnings of local residents.

The benefits of aviation and airports to the local economy show up in many ways:

- lower costs of doing business because of the ease of travel over distances that would be onerous by road
- greater competition due to readier access to alternative markets and suppliers

- improved ability to bring in and send out specialised personnel
- increased investment: a fly in-fly out option improves capacity for investors to effortlessly visit Ballarat to familiarise themselves with the city and to meet prospective clients and business partners
- Potential to attract passenger service stimulating tourism visitation and business travel
- Improved transport access for Ballarat residents contributing to an enhanced quality of life and destination attraction for potential new residents.

Capitalising on previous investment

- Stage 2 of the runway 18/36 upgrade will allow the benefits of the Stage 1 project to be fully realised
- Stage 1 which was co-funded by the Federal Government and the City of Ballarat – added 550 metres to the main runway, taking it to 1,800 metres in length.

Location

 Ballarat Airport, Airport Road, Mitchell Park

Status

- The recommendations and objectives set out in the STAMP are currently being reviewed by the City of Ballarat and – where revenue-generating or minimal cost – are being implemented

 early 2025, with the first LAT due to
 arrive for heavy maintenance at the
 newly constructed Field Air complex at
 the end of the summer fire season.

- Start runway upgrade stage 2
 (if funding is secured) March 2026
- Start terminal and apron works (subject to Council budget processes) – July 2026



The Ballarat Regional MRF will have capacity to sort up to 30,000 tonnes of recyclables annually

The Ballarat Regional MRF will

- Have capacity to sort up to 30,000 tonnes of recyclables annually
- Including kerbside recyclables from City of Ballarat and councils in the Grampians West Region
- Provide opportunities for commercial and industrial commingled waste sorting and recycling

Community Benefit

Circular economy-focused solutions for City of Ballarat's waste streams will:

- Reduce the impact and costs associated with waste management
- Facilitate development of a true circular economy
- Show councils and governments are leading in approaches to environmental sustainability

Why should Governments invest in this project?

Emissions Reductions

A CEP and MRF will support the establishment locally of waste management businesses and infrastructure, reducing the need for the transportation of regional waste to metropolitan areas for processing.

This will mean:

- Annual savings of approximately 65,000 kms
- Almost \$750,000 savings in transport cost
- Associated emissions savings of approximately 65t CO2-equivalent.

Job Creation

Jobs during construction, plus 68 FTEs (24 direct and 44 flow-on) once the MRF is operational



Replace redundant humidifiers and boilers (HVAC) to ensure the Art Gallery of Ballarat (AGB) collection is preserved, and to enhance the AGB's ability to attract loans and host national and international exhibitions.

Inadequate environmental conditions cause disastrous damage to a gallery collection. The upgrade will reduce the significant reputational risk to the City of Ballarat and result in a reduction in electricity and maintenance costs.

Lining the walls of each gallery will enable the AGB to stop hanging artworks on wires which is inefficient and not best practice for a major regional Gallery.

Wires are a security risk as they fail and works can be lifted off and removed.

The heritage walls are unstable and unsuitable for contemporary hanging systems.

The new linings will enable works to be fixed directly to the wall; improved display infrastructure will mean the AGB can more efficiently and safely undertake changeovers, meaning more artworks can be displayed and more borrowed.

Why should Governments invest in this project?

Community Benefit

With 10,500 plus artworks conservatively valued at over \$130 million, the AGB's collection is one of the top five in the country, and the best in regional Australia. It includes some of the most significant paintings of the Australian Impressionists, works related to the Eureka rebellion and early exploration, printmaking and contemporary works.

The AGB hosts over 30 exhibitions and 150 programs and events annually, including international exhibitions.

This is a unique opportunity for a threeway funding partnership between governments.

A small financial commitment, will have an enormous intergenerational impact, demonstrating support and solidarity for all survivors of sexual violence.



City of Ballarat is seeking government support to deliver its Kindergarten Infrastructure Pipeline, a key element of Council's Community Infrastructure Plan 2022-2037.

Council is planning ahead to ensure it can meet the demand for kinder places which has surged as a result of population growth and the Victorian Government's popular Best Start, Best Life Reforms which made kindergarten free for three and four-year-olds from 2023.

Building Blocks Partnership

These policy changes are driving the need for additional early years infrastructure, particularly in Ballarat's growth areas.

City of Ballarat is seeking a Building Blocks Partnership with the Victorian Schools Building Authority (VSBA) to deliver the critical early years infrastructure needed to increase kindergarten capacity across the municipality.

Existing Infrastructure

City of Ballarat owns 18 kindergartens across the municipality which are a mix of integrated and standalone settings consisting of one or two rooms of varying condition.

Kindergartens have numerous developmental benefits for young children:

- Enhancing school readiness and learning and development opportunities
- Children who attend a kindergarten program are less likely to be developmentally vulnerable at school
- Learning key skills including creative thinking, social and emotional skills, and early literacy and language skills
- Children in Year 3 who attended kindergarten were 15 to 20 weeks ahead of those who did not
- At 16, students who attended two to three years of kindergarten had higher scores in English and maths
- Government investment in early years education leads in the long term to higher productivity and earning capacity for children, and reduced government spending on health, welfare and crime

Why should Governments invest in these projects?

Address disadvantage

Data from the 2021 Australian Early Development Census shows Ballarat compares consistently with Australian and Victorian averages, with:

- 1 in 5 children vulnerable on at least one development indicator
- 1 in 10 children vulnerable on two or more development indicators
- However Ballarat has pockets of higher vulnerability with a significant increase in vulnerability experienced in these suburbs between 2018 to 2021:
- Mount Pleasant / Golden Point on all 4 domains (physical, social, emotional, language)
- Sebastopol 3 domains (social, emotional, language)
- Delacombe on 2 domains (social, emotional)

Respond to Government's Universal Kindergarten Policy

Local Government has been tasked with primary responsibility to provide the infrastructure needed to deliver on the Victorian Government's early year's sector reform.

City of Ballarat Council needs a Building Blocks agreement to enable the roll out. Without such an agreement assuring delivery of kindergarten infrastructure for the next decade, Ballarat will have an infrastructure supply problem when future three-year-old kindergarten registrations match four-year-old kindergarten registrations.

Respond to Growth

Ballarat's population is projected to grow to 170,000 by 2041 based on an annual average growth rate of 2.1 per cent, an increase of 57,947 people.

New Growth Areas

Ballarat's three new growth areas -Northern, Western and North-Western will be home to thousands of residents:



In the past three years major events held in Victoria Park have generated an economic value of approximately \$30 million and attracted more than 100,000 attendees, more than half of whom stayed more than one night.

Presently, use of Victoria Park for large events requires sports clubs and other community groups to be displaced while the event is bumped in and out, and for longer periods if remediation works are needed after events. A dedicated events precinct in Victoria Park will allow large scale events to be held year-round with minimal disruption to sports and community clubs which use the park for events, training and matches.
