#### **PURPOSE**

1. The report outlines the process and statutory requirements for the election of the Mayor for the City of Ballarat in accordance with section 25 of the *Local Government Act 2020* (the Act) and section 3.5.4 of Council's Governance Rules.

#### **BACKGROUND**

2. In accordance with Council's Governance Rules, nominations for the position of Mayor were invited to be submitted to the Chief Executive Officer between Wednesday, 13 November 2024 and Monday, 18 November 2024.

#### **KEY MATTERS**

- 3. In accordance with section 25 of the Act and section 3.5.1 (b) of Council's Governance Rules, Council must determine by resolution whether the Mayor is to be elected for a 1-year term or a 2-year term.
- 4. The Mayoral election must be chaired by the Chief Executive Officer who will call for nominations once the Mayoral term has been resolved.
- 5. The Mayor must be elected by an absolute majority of the Councillors to be declared.
