

NUISANCE DOG RESOLUTION GUIDE





The City of Ballarat's Animal Services Team have developed this guide to assist residents to reach a resolution in a timely manner regarding a nuisance being caused by a dog allegedly barking.

A City of Ballarat authorised Animal Management Officer ("AMO") will be responsible for investigating an alleged dog barking nuisance and will rely on the information provided by the dog owner, the resident/s being aggrieved by the nuisance along with surrounding residents to ensure a balanced and fair investigation is conducted.

This guide is to inform you of our current policies and procedures, the investigation process and to provide education to the dog owner to assist with determining any behavioural issues that the dog/s may be expressing or that the owner may need to implement as a responsible pet owner.

During the investigation, the AMO will also check on the registration of all animal/s at the property and detect if there are excess dogs that may require an excess animal permit pursuant to the City of Ballarat's Community Local Laws 2017. If an excess animal permit is required, an application form will be provided to the dog owner along with education around the responsible keeping of animals in excess of the allowed number in a residential area.

When investigating an alleged nuisance, the AMO relies on the provisions of the *Domestic Animals Act 1994* ("the Act") specifically section 32(2), which refers to a dog or cat being regarded as a nuisance if; *it injures or endangers the health or any person or if it creates a noise, by barking or otherwise, which persistently occurs or continues to such a degree or extent that it unreasonably interferes with the peace, comfort or convenience of any person in any other premises.* See except below:

DOMESTIC ANIMALS ACT 1994 SECT 32 Dogs or cats creating a nuisance

(1) The occupier of any premises where a dog or cat is kept or permitted must not allow that animal to be a nuisance.

Penalty: 1 penalty unit.

(2) A dog or cat is to be regarded as a nuisance for the purpose of this section -

(a) if it injures or endangers the health of any person; or

(b) if it creates a noise, by barking or otherwise, which persistently occurs or continues to such degree or extent that it unreasonably interferes with the peace, comfort or convenience of any person in any other premises.

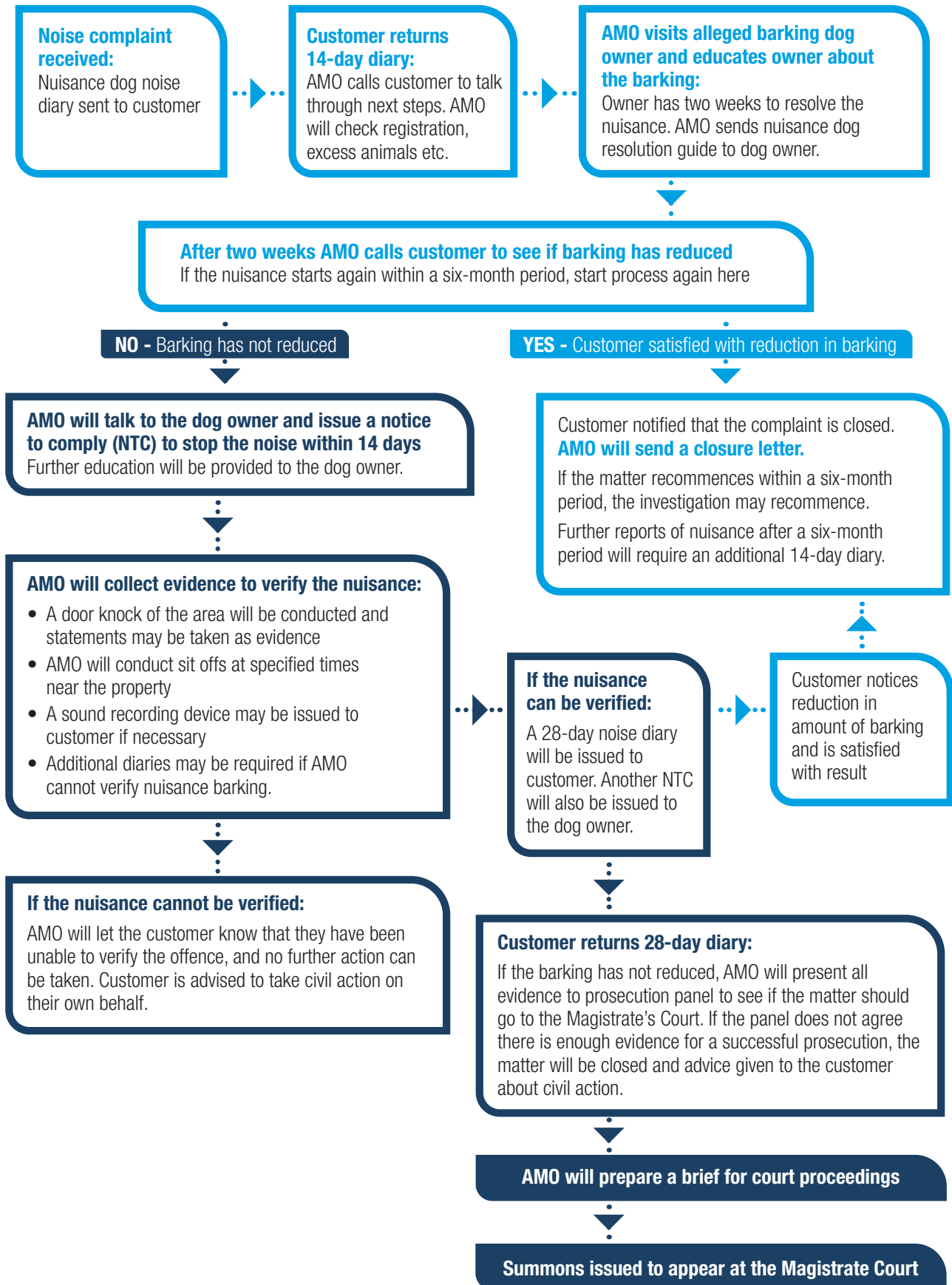
Our aim is to resolve the nuisance so that all parties can resume the peace and quiet enjoyment of their residence as soon as possible however, in some instances, the matter may be required to be brought before a Magistrate. The person/s being aggrieved by the dog will be required to give evidence in such cases and the dog owner could be ordered to abate the nuisance or receive a punitive penalty (infringement), or both.

Noise diaries will be required as evidence of the nuisance. It is important that the complainant/s report the affect the nuisance is having based on the definition listed above (section 32 of the Act) and are willing to give evidence if required to support the alleged nuisance in Court.

It is important that the aggrieved person/s understand that the AMO will request multiple diaries to be completed over the course of the investigation. The first diary to be completed is a 14 day noise diary (page 5 of this document). If required, the AMO will advise when to complete the further 28 day diary and/or additional diaries.

BARKING DOG INVESTIGATION FACT SHEET

Why do dogs bark?

Barking is a normal behaviour for dogs and is one way they communicate with the world.

To resolve a nuisance barking complaint it is important to distinguish between stimulated and nuisance barking.

Stimulated barking

When a dog barks in a direct response to a stimulus it is known as stimulated barking. This part of normal dog behaviour and is typically not considered a nuisance unless it continues for an extended period of time or frequently occurs at an unreasonable time of day.

Examples of stimulated barking:

- Barking in response to the presence of another dog or person
- Barking at birds , possums or other wildlife
- Barking in response to loud noises such as heavy machinery or doors closing
- Excited barking from playing with a person or other dog

Nuisance barking

Dog barking can be regarded as a nuisance if it unreasonably interferes with the peace, comfort or convenience of any person.

Whether or not the barking is considered reasonable depends on the duration, time of day and the cause of the barking.

Examples of nuisance barking:

- Barking for long periods of time due to boredom or stress
- Barking that begins as stimulated barking but continues for an unreasonable amount of time
- Barking that frequently occurs at an unreasonable time of day, such as late at night or early in the morning.



NUISANCE COMPLAINT

The first step is to talk to your neighbour as early as possible and try to resolve the problem good-naturedly. If this is unsuccessful, please complete the first report of nuisance dairy (14 days) and return to us for investigation.

Should you decide **not** to go to court and given evidence, the City of Ballarat can provide education to the dog owner, but cannot investigate the matter any further if the nuisance continues.

BARKING DOG INVESTIGATION FACT SHEET

If you have a dog in your neighbourhood who is causing issues with its barking, a City of Ballarat authorised Animal Management Officer can investigate.

When investigating an alleged nuisance, our AMOs follow the *Domestic Animals Act 1994*.

Section 32 of the Act states a dog of cat is a nuisance if:

- It injures or endangers the health of any person or if it creates a noise, by barking or otherwise, which persistently occurs; or
- Continues to such a degree of extent that it unreasonably interferes with the peace, comfort or convenience of any person in any other premises.

It is important that you report the affect the nuisance is having based on the definition in the Act and are willing to give evidence in Court if needed.

You may need to keep multiple diaries as part of the noise complaint investigation. The first diary is a 14 day noise diary. If needed, the AMO will let you know when to complete the 28 day diary or a further 7 day diary.

There may be times when a matter can't be resolved quickly and needs to be before a magistrate. The person/s being aggrieved by the dog will need to give evidence and the dog owner could be ordered to abate the nuisance, remove the dog, receive a punitive penalty, or both.
