

### **Summary of Personal Interest Returns December 2024**

#### Including Biannual Personal Interest Returns September 2024

The Local Government Act 2020 states that councillors, members of delegated committees and key council staff must submit a record of their personal interests to the Councils' chief executive officer (CEO).

The Local Government (Governance and Integrity) Regulations 2020 set out that the following interest must be declared:

- 1. Corporate directorships or memberships of a governing body
- 2. Unincorporated associations in which you are a member and perform a leadership role
- 3. Business partnerships or joint ventures which you are a member
- 4. Trusts that you are a trustee or a beneficiary of
- 5. Any paid employment in the preceding 6 months where the income exceeds \$10,000 in that period
- 6. Consultancies, contracts or agents where your payments exceeded \$10,000 in the preceding six months
- 7. Land you own or have a beneficial interest in within the municipal district of the Council or an adjoining municipal district
- 8. Shares you own or have a beneficial interest in where the total value of the company does not exceed \$10 million and the combined total value of the shares is more than \$10,000
- Companies which you solely or jointly, with family members hold a controlling interest
- 10. Personal Debt over \$10,000 (excluding financial institutions)
- 11. Gifts Received
- 12. Other Interests
